4. Entry Restrictions:	<p>Entry to the Promotion is open to all Australian residents, who fulfil the entry requirements. Entrants who are under 18 but have the permission of their parent / legal guardian are eligible to enter.</p> <p>Directors, management, employees, officers and contractors (and their Immediate Families) of the Promoter or of the agencies or companies associated with this Promotion are ineligible to enter.</p> <p>"Immediate families" means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin) whether or not they live in the same household as the director, manager, employee, officer or contractor.</p>

<p>12. Prize Draws:</p>	<p>Randomdraws.com.au (by TPAL), a government certified service provider, will conduct the random electronic draw on behalf of the Promoter.</p> <p>The Prize Draw will take place at Museum of Contemporary Art – Level 4, 140 George Street, Sydney NSW 2000 at 9:00am AEST on Wednesday 8 July 2026. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn or otherwise forfeited.</p>
<p>13. Prize Redemption:</p>	<p>The winner will be provided with a voucher or booking reference to redeem their Prize directly with Falls Creek within 30 days of being notified. The winner must contact Falls Creek directly to arrange their visit, subject to availability and Falls Creek’s applicable resort conditions. The Promoter will use its best efforts to ensure that the winner is notified of any delays in prize fulfilment.</p>
<p>14. Winner Notification:</p>	<p>The winner will be notified in writing (by email) by 5:00pm AEST on Wednesday 8 July 2026. They will be contacted via the phone number provided upon entry if there is no response to the email within 2 business days.</p>
<p>15. Prize Claim & Prize Claim Deadline:</p>	<p>The winner must claim the Prize within 2 business days of the Promoter's initial winner notification email, or, if the Promoter subsequently contacts the winner by phone, within 2 business days of that phone notification.</p>

Second Chance Prize Draw:</p>	<p>If the Prize winner does not respond within the Prize Claim Deadline (2 business days of notification), the Promoter will move to the next reserve entry drawn at the time of the relevant Prize Draw (in order of draw). This process will continue until a valid, responsive winner is confirmed.</p> <p>Any reserve winner will be notified within 1 business day of the previous winner forfeiting their prize. The reserve winner must also claim their Prize within 2 business days of notification in accordance with Item 15.</p>

TERMS AND CONDITIONS

1. These terms and conditions must be read together with the Schedule for this Promotion. The Schedule defines certain terminology used in these Terms and Conditions. Participation in the Promotion constitutes acceptance of these Terms and Conditions. To the extent of any inconsistency between the Schedule and these terms, the Schedule prevails.

Entry

2. By entering the Promotion, entrants agree to be bound by these Terms and Conditions. Entries must comply with these Terms and Conditions to be valid.
3. Individuals can only enter this promotion during the Promotion Period. All entries must be received by the Promoter before the end of the Promotion Period. Entries are deemed to be made at the time of receipt by the Promoter, not the time of transmission by the entrant. Entries received after the Promotion Period will not be accepted.
4. Entrants may submit up to the Maximum Number of Entries.
5. The Promoter accepts no responsibility for any late, lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries whether due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption, communications failure or otherwise.
6. The Promoter takes no responsibility should an individual not be able to access the Website. Any cost associated with accessing the internet or loading data on a mobile device is the sole responsibility of the entrant and is dependent on the internet/mobile service provider used.

Prize

9. The Prize winner will be notified in accordance with the Winner Notification. The winner must claim their Prize in accordance with the Prize Claim and by the Prize Claim Deadline. A winner who does not abide by this clause 9 will forfeit their prize.
10. The Prize will be redeemed by the winner in accordance with the Prize Redemption at Item 13 of the Schedule. The Promoter is not responsible for any delay in prize fulfilment caused by Falls Creek or any third party.

Where any element of the Prize is unavailable for any reason, including resort closure due to weather, insufficient snow cover, or other circumstances beyond the Promoter's or resort's reasonable control, the Promoter may substitute for that Prize another item of equal or higher value as determined by the Promoter, subject to any required regulatory approvals.
16. The Prize does not include flights, transfers, accommodation, food, beverages, travel insurance or any other costs not expressly listed in the Prize description. All ancillary costs associated with redeeming the

Prize are the sole responsibility of the winner.

Publicity

By providing your personal information to us, you consent to the collection, use, storage and disclosure of that information as described in the Promoter's Privacy Policy. If you provide us with personal information on behalf of another person, you warrant that you have the person's consent to so do, have provided that person with the Promoter's Privacy Policy and a copy of these Terms and Conditions, in collecting and storing that information, you are complying with the Privacy Act 1988 (Cth). General

21. The Promoter's decision in relation to all aspects of this Promotion is final and no correspondence will be entered into.
22. The Promoter reserves the right, in its sole discretion, but shall not be under any obligation, to verify the validity of any entry or any information provided by an entrant (including his or her identity, residential address and any other information relevant to entry into, or participation in, this Promotion). The Promoter may, in its sole discretion, disqualify any individual who submits an entry that in the sole opinion of the Promoter is not in accordance with these Terms and Conditions or who provides false information, fails to provide information, conspires with others to gain an unfair advantage or who is otherwise involved in manipulating, interfering or tampering in any way with this Promotion.
23. If this promotion is interfered with in any way or is not capable of being conducted or administered as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, acts of god, acts of terrorism or war (declared or undeclared), state of emergency, disaster, resort closure, technical failures, security breaches, tampering, or computer viruses, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
24. Without limiting any other paragraph, the Promoter may at its discretion amend any aspect of this Promotion or of these Terms and Conditions, subject to applicable laws and approval of State and Territory Authorities.
25. Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under Competition and Consumer Act 2010 (Cth), or similar consumer protection laws in the State and Territories of Australia.
26. Except for any liability that cannot be excluded by law, the Promoter and, where applicable, the Promoter's Partners and Suppliers (and their officers, employees and agents) will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits) expense, damage, personal injury or death arising in any way in connection with participation in this promotion, including (but not limited to): (a) accepting or using the Prize, including any incident occurring at any ski resort; (b) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (c) any

theft, unauthorised access or third party interference; (d) any entry or Prize claim that is lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter; (e) any variation in the Prize value; (f) any tax liability incurred by a winner or an entrant; or (g) resort closure or unavailability of prize components due to weather, snow conditions or other circumstances beyond the Promoter's control, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).

29. The laws of New South Wales, Australia apply to this promotion, except to the extent that a different state or territory's trade promotion legislation applies.
